Due to the coronavirus, all branch activities in the near future have been cancelled. Branch 23 officers and the state SIR officers have been in close contact, awaiting news regarding the resumption of branch activities.

BIG SIR REPORT:

To the members of Branch 23, I hope this email finds you and your family in good health.

Spring is here, and where we would normally be entering a beautiful time of year; anticipating social gatherings, golf, gardening, or spending more time with friends, we find ourselves forced to do the opposite.

As anticipated, our group is not exempt from making some necessary changes in order to mitigate the potential spread of the coronavirus. On March 17, 2020 we got word from the state board to end all activities statewide for SIRS. Prior to the notice from the state & SIRs President Ed Benson, our own BEC from Branch 23 had met and we were in the process of setting criteria of how to maneuver through the pandemic. We had planned to follow the Sacramento County Health Department guidelines, but within days of our meeting before our last luncheon, things rapidly progressed and the virus has now interrupted our normal Standard Operating Procedures. This decision to end all SIRS related activities was made in keeping with the new criteria set by the federal government and the State of California, and is the prudent thing to do. As you know, our age group has a high susceptibility to illness and the current coronavirus. Taking precautionary measures is important, but only temporary.

In addition to, but separate from the virus complications, we are faced with an insurance claim that jeopardizes our coverage in the near future. The members of our executive board have knowledge of this situation, and are actively working on a resolution. We will keep you abreast of any new information with regard to this claim. Because of these circumstances, the State board directives are as follows:

- 1) All SIR luncheons and activities will be postponed until further notice.
- 2) If we have any current contractual obligations, we need to speak with our supplier to postpone.
- 3) We are not to enter into any new contractual agreements until further notice.

During this time of uncertainty, we are forced to take drastic measures creating unease and social isolation. Part of our group's purpose is to support each other and stay connected. Please remember that although we are not able to meet face to face, we are still here in support of one other.
