Take exit 135 from I 80 E, 47 min (51.1 mi) Merge onto I-5 N 2.5 mi, Use the right 2 lanes to take exit 522 to merge onto I-80 E toward Reno 8.1 mi, Keep left at the fork to stay on I-80 E, 40.4 mi Take exit 135 toward CA-174 W/Colfax/Grass Valley 262 ft Follow CA-174 W to Rollins Lake Rd
